# **Episode 10: Treaty Relations and Environmental Politics in Canada**

Overview: Reflecting on the history and relationships that underpin two documentary films they made together, Dr. Sherry Pictou and Dr. Martha Stiegman discuss how the Mi'kmaq work to assert treaty rights over their land and fisheries in the face of colonialism and neoliberalism.

### **Key Takeaways**

- Colonialism is often "thought about historically," yet Indigenous scholarship demonstrates how colonization continues to shape institutions and the agency of Indigenous communities today (Dr. Pictou, 10:59-12:44).
- Community-based research takes commitment and work to foster authentic relationships built on trust. This work may be part of a path forward to reconciliation between settlers and indigenous communities.
- Treaties are often understood through the British legal context, at the same time the indigenous legal context includes the 'web of relations" that articulates responsibilities for settlers living within Canada.

### **Discussion Questions**

- 1. How would you describe the similarities and differences between the Peace and Friendship Treaties, articulated by Dr. Pictou, and other treaties within Canada?
- 2. What opportunities do you have to become what Dr. Steigman calls a "good treaty partner" through your own education and experiences?
- 3. Dr. Steigman and Dr. Pictou note there is a relationship between neoliberalism and neo-colonialism; how do you see this relationship express itself in other places both globally and within Canada?
