Episode 15: Climate Action in and by Canada: ENGO Voices

Overview: What role do ENGOs play in the Canadian ecopolitical sphere? Catherine Abreu, Executive Director of Climate Action Network Canada, and Colleen Thorpe, Executive Director of Équiterre walk us through the roles their organizations play in fighting for climate policy and shifting cultural norms in Canada.

- Civil society organizations often bridge the gaps between national and global, building
 collective action and mobilization that may lead to policy solutions across various
 countries. Environmental Non-Governmental Organizations (ENGOs) may work at the
 local community level, nationally, or globally.
- Various types of organized work contribute to change at various levels of governance.
 For example, ENGOs may advocate for change through mobilization, policy work,
 environmental campaigns, and other types of expertise offered through civil society.
- ENGOs work in a challenging political space both nationally and globally, for example, navigating tensions between resource extraction and environmental protection for changing social norms within Canada's national policies.
- The work of Canadian ENGOs is evolving, by, for example, creating a more inclusive movement that recognizes intersectionality and thus the diverse and uneven consequences of the climate crisis within Canada.

- 1. What do you think are obstacles and opportunities for collective action by ENGOs, and other actors, on climate change and related policy within Canada today?
- 2. Thorpe and Abreu discuss the roles that ENGOs may play within ecopolitics. Do you agree that ENGOs are important players in domestic and global climate politics today?
- 3. What difference might having more diverse voices in the climate movement make to the types of actions and policies ENGOs advocate for?
- 4. To what extent do you think cynicism limits both individual and collective action on climate policy within Canada, and what can be done to counter it?
