Episode 8: Indigenous Environmental Knowledge and Politics

Overview: Larry McDermott (Shabot Obaadjiwan First Nation and ED of Plenty Canada) and Dr. Dan Longboat (Turtle Clan member of the Mohawk Nation and Associate Professor at Trent University) discuss lessons for sustainability inherent in Indigenous knowledges as well as Indigenous interpretations of the Royal Proclamation of 1763 and other early treaties.

Key Takeaways

- Indigenous knowledge is intergenerational, building understandings of the world through oral teachings, language and history.
- Haudenosaunee and Anishnaabe environmental knowledge recognizes a good life takes into account the responsibilities for people, non-human beings, and the generations that came before us as well as those that will come after us.
- "To be an Indigenous person ... means that you exude all of those principles and those original instructions that we were given at the time of creation of human beings" (Dr. Longboat, 8:18-9:39).

- 1. How is your own eco-worldview similar or different from the Indigenous perspectives offered in this episode, and why do you think that is?
- 2. What do you think is the legacy of the Treaty process between Indigenous peoples and the Crown in shaping environmental politics in Canada today?
- 3. What is your response to the idea that "value change", as articulated by Dan Longboat, is key to addressing the climate crisis?
